- b. 30mph zone In December last year Highways agreed to carry out a consultation within the village on Council's long-standing request for the zone to be extended further down Crayke Lane. The response from the consultation was positive, and in May the extension was approved. On 6th August engineers came to move the signs to the new location. However, because of an objection on the day from a resident, the signs were not put up. We are pressing Highways to resolve the problem and install the signs to mark the approved extension.

1 - Report on Moveable Vehicle Activated Sign (MVAS) 21st September 2021

After a period of 6 weeks at the West Way junction, the MVAS speed sign was moved to opposite the Sports field. Data collected on traffic incoming along Easingwold Road was compared between 26-30 April 2021 and 23-27 August 2021 (5 weekdays Mon-Fri).

The daily number of vehicles passing was significantly lower in August at between 696 and 784 per day in August, compared with 1454 to 1652 in April. This may be due to the holiday period, or due to the fact that many people were working from home in April, during Covid restrictions, or possibly other factors unknown.

The weekday average speeds were 21-95 to 27.02 mph in April versus 24.24 to 28.14 mph in August, very similar and comfortably within the speed limit.

The weekday 85th percentile speeds recorded were 28.12 to 31.8 mph in April versus 28.86 to 32.86 in August, i.e., not greatly different and not of serious concern.

The data collected on a similar five weekday period (5-18 July) on West Way (incoming from Stillington direction) showed average daily vehicle count of 818, average speed of 26.2 mph and 85th percentile of 32.5 mph, again very similar to the August data above.

Conclusions: There appears to have been a reduction in vehicle counts over the summer months and following the end of Covid19 restrictions. Vehicle speeds have generally settled to consistently within the speed limit on average, although a small proportion still exceed the limit *especially early mornings and late evenings.

We will keep collecting and analysing data, and where appropriate, communicate the results to Highways and to NY Police.

85 percentile speed is the speed at which 85% of vehicles were below (i.e., one in six exceeded this speed.)

The MVAS does not take photographs nor record vehicle registrations.
